# ELECTRICAL WORKERS HEALTH AND WELFARE FUND

This is a summary of the annual report of Electrical Workers Health and Welfare Fund, EIN 41-6024782, for the year ended December 31, 2019. The annual report has been filed with the Employee Benefit Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of the Plan has committed to pay medical, prescription drug, dental, disability, vision and vacation benefits incurred under the terms of the Plan.

# **INSURANCE INFORMATION**

The Plan maintains a stop-loss arrangement with BlueCross BlueShield in an effort to limit its exposure for self-insured benefits in addition to a contract to pay retiree claims incurred under the terms of the Plan. The total premiums paid for the policy year ending December 31, 2019 was \$2,061,517.

#### BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the Plan was \$20,349,847 as of December 31, 2019, compared to \$19,227,789 as of January 1, 2019. During the plan year, the Plan experienced an increase in its net assets of \$1,122,058. This increase included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the Plan had total income of \$18,481,050 including, but not limited to, employer contributions of \$14,461,863; participant contributions of \$1,953,347; earnings on investments of \$1,699,972; and other income of \$365,868.

Plan expenses were \$17,358,992. These expenses included \$388,874 in administrative expenses and \$16,970,118 in benefits paid to or for participants and beneficiaries.
